Dear Professor Quaranta,

Congratulations on your endeavour to achieve high quality of care in your Institute through the OEIC Accreditation and Designation. The OEIC is committed to shaping the future of oncology by promoting cancer care and research, through education, quality, integrity, service, leadership, innovation and multidisciplinary. The OEIC strives to make the accreditation process an insightful and collegiate opportunity to learn, grow and improve.

I remind you that the participation to the Accreditation and Designation is subject to the signature of an agreement between the OEIC and your Institute and therefore it is my pleasure to send you attached to this letter (Annex 1: Doc 06) the OEIC Accreditation & Designation Agreement to be signed by the authorised representative of your cancer centre.

Following the agreement with the Italian National Institute of Health (ISS), the Italian CCCs are subject to the payment of a special rate of accreditation fee of 22.500 Euros of which the amount of 15.000 Euros will be supported by the ISS and the remaining 7.500 Euros will be invoiced to your Institute. The total payment must be made in three Stages. The first and the third will be paid by the ISS. The amount due by your Institute is therefore the Second Stage corresponding to an amount of 7.500 Euros. This amount shall be paid when the self-assessment period has been finalized and your Institute is approved for the peer review which will be held only after having received the payment for the Second Stage.

To participate to the OEIC Accreditation and Designation, the Institute must also be in compliance with the payment of the annual OEIC membership fee.

The OEIC A&D WG is pleased to help you to achieve the prestige of accreditation in the crucial field of cancer research and care.


